

**SANDS WILD WATER RIVER TRIPS  
NOTICE OF RISKS OF ACTIVITY**

**For over 40 years Charlie Sands Wild Water River Trips has provided safe and exciting river adventures for more than one million clients. Each participant on a Sands Wild Water adventure understands and acknowledges that certain risks are integral or inherent to the recreational activity. Our staff is available to answer any questions about such risks, including loss or damage to personal property, illness, accidental personal injury, permanent trauma or death, including without limitations by way of example:**

1. **Risk of hypothermia or drowning and trauma** caused by hot sun or cold water, including being wet, cold and uncomfortable;
2. **Related risk of getting to, in or out of the river or boats** caused by slippery, uneven or unstable ground or vessel surfaces;
3. **Risks of head or other bodily injury** from being thrown by the forces of the water, out of the raft or boat onto rocks or trees or into dangerous rocks or cold water, gear, cargo, rigging or other people;
4. **Risk of exposure to sunburn, poison ivy, insect bites and stings** or other wildlife or animal encounters;
5. **Risk of injury during vehicular transportation to or from the river**, and such other risks, hazards and dangers that are integral to high mountain river activities in a wilderness environment.

Each participant on a Charlie Sands Wild Water trip does so voluntarily, with full knowledge of the risks and assumes all risks of participation. Each participant has a duty to disclose any mental or physical limitation which may affect participation.

I recognize there is an element of risk in any adventure, sport, or activity associated with the outdoors. I certify that my family and I, including minor children, are fully capable of participation in the said activity.

I assume full responsibility for personal injury to myself and, if applicable, to my family for loss or damage to personal property and related expenses as a result of my negligence or the negligence of my family participating in the activity, except to the extent that such damage or injury may be due to the negligence of Sands Wild Water River Trips. I further understand that Sands Wild Water River Trips reserves the right to refuse any person it judges to be incapable of meeting the rigors and requirements of this activity. Any legal claims that may arise from participation in this activity shall be resolved under Wyoming law in the courts of Wyoming.
